This may have recharge implications and would also require engagement with residents (alongside design and delivery resources). The Green Space team would be able to support delivery of such a project, but this would need to be programmed into the Green Space Investment Programme, and officer time would need to be funded from the bid. This would be hard to cost without further detail but please let us know if the DMC are willing to provide funding and an idea of the amount available.
